ORDER

The Principal, College of Applied Science, Thamarassery, Kozhikode(Dt.) had applied for starting the new Self financing courses of M.Com and MA English for the academic year 2015-16 and 2016-17, vide paper read as 1st.

As per paper read as 2nd, the District Level Inspection Commission conducted inspection at the College and recommended the Self financing courses of MA English and M.Com with an intake of 15 students for each and the University forwarded the same to the Govt. for concurrence, vide letter read as 3rd.

Vide paper read as 4th, the Govt. have granted administrative Sanction for starting the new Self financing courses of MA English and M.Com with an intake of 15 students in College of Applied Science, Thamarassery, Kozhikode(Dt.) for the academic year 2015-16.

As per the paper read as 5th, the Principal, College of Applied Science, Thamarassery has requested to grant Provisional affiliation to the above mentioned new courses during the academic year 2015-16 remitting an amount of Rs.20,000/-(Twenty thousand only) towards affiliation fee vide chalan No.151555092 & 151555109 dated 07.07.15 at SBT. He has also submitted a notarised Undertaking duly signed by the Director and the Principal of the College.

Considering the above, the Vice Chancellor as per the decision of the Syndicate dated 21.07.2015, vide Item No.2015.978*, has ordered on 04-08-15, to grant provisional affiliation to the new Self financing courses of M.Com (15 seats) and MA English (15 seats) in College of Applied Science Thamarassery, Kozhikode for the academic year 2015-16.
