ORDER

As per the letter read as (2) the Standing Counsel for University of Calicut has informed that considering the W.P (C) No. 12190/20L3 filed by Al - Hind Educationat & Charitable Society against University of Calicut and others the court has passed an interim order directing the University to grant provisional affiliation to the College of the Petitioner before 15.05.2013. It is made clear that in case, the Syndicate is not in session, the Vice Chancellor shall exercise his powers under the Statute in passing the orders.

The late application that was submitted by the educational agency for starting the new college during 2012-13 & 2013-14 was rejected as per provisions in the statute. But the District level Inspection Commission for Malappuram as per the report read as 1, recommeded five branches of B.Tech Courses - Mechanical Engineering, Civil Engineering, Electrical Electonic Engineering, Electrical Communication Engineering- with 60 seats each in Ernad Knowledge city Technical Campus, Manjery, Malappuram and the recommendation was approved by the Syndicate and forwarded to Govt. for consideration.

Govt. of Kerala have not issued the administrative sanction and NOC for starting the new college.

The All India Council for Technical Education, vide letter read (3) has conveyed its approval for starting the following courses in the college for the academic year 2013-14.

The Institution has remitted Rs.3,40,000/-(Rupees Three lakhs fourty thousand only) viz.Chalan No. Nil dated 13.03.2013 towards fee for administration and affiliation.

Considering the above, sanction has been accorded by the Vice-Chancellor for provisional affiliation for starting a new college Ernad Knowledge city Technical Campus, Manjeri. Malappuram with the following BTech programmes with the intake of students shown against each, under the management of Al-hind Educational Trust for the academic year 2013-14, subject to the final disposal of the W.P.(C) No.12190 of 2013(W).

Selection and admission shall be made only on the basis of rules and regulations of the University/Government and on the basis of the directions issued by the University/Government by time to time failing which the affiliation granted will automatically be cancelled.

In the light of the direction of the Supreme Court of India in WP(C) 656/1998 the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.

Affiliation granted is strictly provisional and only for the academic year 2012-13. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of the letter of extension of approval from the apex bodies concerned.

Admission to the next academic year shall be made only after obtaining prior permission from the University.
