ORDER

An application was submitted by the Principal, Little Flower College, Guruvayur for additional affiliation for starting BA Functional English and MA Virtual Communication courses in the college for the academic years 2013-14 & 2014-15 vide paper read as 1st.

The Inspection commission, vide paper read as 2nd, recommended the BA Functional English with an intake of 24 seats and MA Multimedia course with an intake of 15 students was also recommended as per the request from the Principal, instead of MA Virtual Communication since the syllabus of both the courses are the same. As per resolution on Item No. 2013.436 dated 27.5.2013, the Syndicate accepted the request for MA Multimedia course. Recommendation of the University was forwarded to Government for consideration and concurrence.

The Government of Kerala, vide paper read as 3rd, have granted Administrative Sanction for starting the Self Financing courses of BA Functional English and MA Multimedia with an intake of 24 and 15 students respectively in Little Flower College, Guruvayur for the academic year 2013-14.

After signing an agreement with the Educational agency, the government have issued No Objection Certificate for starting the said Self Financing courses in the college with an intake of 24 and 15 students respectively for the academic year 2013-14 vide G.O read as 4th.

As per paper read as 5th, the Principal has requested to grant additional affiliation for starting the above-mentioned courses in the college for the academic year 2013-14. An amount of ₹ 10,000/- (Rupees Ten Thousand only) was remitted towards affiliation fee vide chalan No. 26 & 27 dated 14.06.2013 at SBT, Chavakkad. A notarised undertaking to the effect that they will carry out faithfully the provisions of the University Act, Statutes etc. was also produced.

Vide paper read as 6th, the Vice Chancellor has ordered to grant additional affiliation for starting the Self Financing courses of BA Functional English and MA Multimedia courses with an intake of 24 and 15 students respectively in Little Flower College, Guruvayur for the academic year 2013-14 as per the provisions of Calicut University Act, Chapter III, Section 10(13).

Additional affiliation is, therefore, granted for starting the Self-Financing/Unaided courses of BA Functional English and MA Multimedia with an intake of 24 and 15 students respectively in Little Flower College, Guruvayur for the academic year 2013-14 as per the Calicut University Act, Chapter III, Section 10(13).

Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled.

In the light of the directions of the Supreme Court of India in WP(C)656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances appropriate action including withdrawal of affiliation of the college will be initiated.

Affiliation granted is strictly provisional and only for the academic year 2013-14. The college has to apply for continuation of provisional affiliation for the ensuing years, remitting the fee fixed by the University.

Admission to the next academic year shall be made only after obtaining prior permission from the University.

Orders are issued accordingly.
