ORDER

The Principal, Sacred Heart College, Chalakkudy, Thrissur, had submitted an application for starting of new course of B.Com (Finance) during the academic year 2013-14 & 2014-15 vide reference (1) above.

The University appointed an Inspection Commission to verify the facilities in the college for teaching the course and the Inspection Commission after conducting an inspection on 23.03.2013, recommended the new course of B.Com with an intake of 40 seats vide reference (2) above and the University recommended the same to the Govt. for concurrence.

The Government issued Administrative Sanction for starting the new Self-financing course of B.Com (Finance) with an intake of 40 seats at Sacred Heart College, Chalakkudy, Thrissur for the academic year 2013-14 vide reference read as (3) above.

After executing an agreement with the educational agency, the Government also issued a No-objection certificate for starting the new self-financing course of B.Com Finance with 40 seats in Sacred Heart College, (Aided), Chalakkudy, Thrissur during the academic year 2013-14 vide reference (4) above.

Considering the above, the Hon. Vice Chancellor has granted permission for additional affiliation of the new self-financing course of B.Com with Finance in Sacred Heart College, Chalakudy, Thrissur during the academic year 2013-14 as per reference (5) above subject to report to the Syndicate, as per CU Act 1975 Chapter-III Section 10(13).

An Undertaking to the effect that they will carry out faithfully the provisions of the University Act, Statutes, Ordinances etc in stamp paper worth ₹100/- attested by the advocate, Notary has also been submitted by the Principal and the Manager. Affiliation fee of ₹5,000/- (Rupees five thousand only) has been remitted vide chalan No. 128 dated 25.10.2013 at SBT, Chalakudy branch.

Sanction is therefore accorded for granting additional affiliation for the following new self-financing course in Sacred Heart College, Chalakudy during the academic year 2013-14 subject to report to the Syndicate, as per CU Act 1975 Chapter-III Section 10(13).

Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled.

In the light of the directions of the Supreme Court of India in WP(C)656/1998 the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances appropriate action including withdrawal of affiliation of the college will be initiated.

Affiliation granted is strictly provisional and only for the academic year 2013-14. The college has to apply for continuation of provisional affiliation for the ensuing years, remitting the fee fixed by the University.


