**ORDER**

The Principal, Christ College, Irinjalakuda, Thrissur vide reference (1) had submitted an application for starting new self-financing courses of (1) B.Com-additional batch, (2) BCA, (3) BSW, (4) BA Malayalam, (5) MA English and (6) M.Sc Botany for the academic year 2013-14 & 2014-15.

An Inspection Commission was constituted to verify the facilities available in the college to teach the subjects and the Inspection Commission vide reference (2) recommended for starting of the new courses in the college. The University recommended the same to the Government for consideration and concurrence.

The Government of Kerala vide paper read as (3) have accorded Administrative Sanction to start the new courses. After signing an agreement with the Educational Agency, the Government vide paper read as (4) have also issued a No-Objection Certificate to start the new self-financing courses of (1) B.Com-additional batch, (2) BCA, (3) BSW, (4) BA Malayalam, (5) MA English and (6) M.Sc Botany for the academic year 2013-14. in Christ College (Aided), Irinjalakuda, Thrissur with an intake of 40, 24, 24, 40, 15 & 12 students respectively.

Considering the matter, the Hon. Vice Chancellor vide reference (5) has accorded sanction for granting provisional affiliation to the abovementioned new self-financing courses in Christ College, irinjalakuda, Thrissur and report to the Sydnicate, as per Calicut University Act, Chapter-III Section 10(13).

An Undertaking to the effect that they will carry out faithfully the provisions of University Act, Statutes, Ordinances etc in stamp paper worth ₹100/- attested by the advocate, Notary, has also been submitted by the Principal and Manager of the college.

The required affiliation fee of ₹30,000/-(Rupees thirty thousand only) have been remitted vide chalan No. 1299201 & No.1299202 dated 29.06.2013 at the chalan counter, University of Calicut.

Sanction is therefore accorded for granting additional affiliation for the following new self-financing courses in Christ College (Aided), Irinjalakuda, Thrissur for the academic year 2013-14 exercising the provision as per Chapter III, Section 10 (13) of the Calicut University Act.

Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled.

In the light of the directions of the Supreme Court of India in WP(C) 656/1998 the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances appropriate action including withdrawal of affiliation of the college will be initiated.

Affiliation granted is strictly provisional and only for the academic year 2013-14. The college has to apply for continuation of provisional affiliation for the ensuing years, remitting the fee fixed by the University.
