ORDER

The President, St. Teresa's Educational and Charitable Trust, Kottakkal, Mala, Thrissur had submitted an application for granting affiliation to a new Self-financing College by name "St.Teresa's Arts & Science College" during the academic year 2013-14 & 2014-15 with courses of B.Com with Finance, B.Com with Co-operation, and BBA, vide paper read as 1st.

The University appointed an Inspection Commission to verify the facilities available in the proposed site and the Commission after Inspection on 23.03.2013 recommended the project with the courses of B.Com with Finance, B.Com with Co-operation, and BBA with the intake of 40 students each for the academic year 2013-14 & 2014-15, vide paper read as 2nd and the University forwarded the same to the Govt. for consideration and concurrence, in the wake of the provisions stipulated in the UGC (Affiliation of Colleges by Universities) (1st Amendments) Regulations, 2012, pertaining to the requirement of land for starting new colleges.

The Govt. vide G.O read as 3rd, have accorded Administrative Sanction to start the new Self-financing/Unaided college with name and style of "St. Teresa's Arts & Science College", Kottakkal, Mala, Thrissur during the cademic year 2013-14 with the new courses of B.Com with

Finance, B.Com with Co-operation and BBA with an intake of 40 students each under the management of St. Teresa's Educational and Charitable Trust, Kottakkal, Mala, Thrissur.

The Government have also issued a No-objection Certificate for starting the above Self-financing/Unaided college with the above mentioned courses vide G.O. read as 4th.

The Syndicate, vide Item No.2013.*360 dated 16.5.2013 (Emended vide Item No.2013.429), has resolved that the final verification of the land documents can be done while issuing affiliation order. The Convenor of the District Level Inspection Commission, Thrissur has certified that he has verified the documents of land and found that the Trust possesses enough land without any incumbrances required to start the proposed college.

Vide paper read as 5th, the Syndicate has resolved to grant provisional affiliation for starting the new Self-financing/Unaided college with the name and style of "St. Teresa's Arts & Science College", Kottakkal, Mala, Thrissur during the anademic year 2013-14 with the new Self-financing/Unaided courses of B.Com with Finance, B.Com with Co-operation and BBA with an intake of 40 students each, under the management of St. Teresa's Educational and Charitable Trust, Kottakkal, Mala, Thrissur.

The Educational agency, as per paper read as 6th, has submitted a notarised undertaking duly signed by the Principal and the Manager of the college and remitted an amount of $\frac{7}{55,000}$ (Rupees Fifty five thousand only) towards administration and affiliation fee , vide chalan dated 31.5.2013 at SBT, Calicut University Branch.

Provisional affiliation, is therefore, granted for starting the new Self financing/Unaided college with the name and style of "St. Teresa's Arts & Science College", Kottakkal, Mala, Thrissur during the cademic year 2013-14 under the management of St. Teresa's Educational and Charitable Trust, Kottakkal, Mala, Thrissur with the following Self-financing/Unaided courses and with intakeof students noted against each.

Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled.

In the light of the directions of the Supreme Court of India in WP(C)656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances appropriate action including withdrawal of affiliation of the college will be initiated.

Affiliation grated is strictly provisional and only for the academic year 2013-14. The college has to apply for continuation of affiliation for the ensuing years, remitting the fee fixed by the University.

Admission to the next academic year shall be made only after obtaining prior permission from the University.

Orders are issued accordingly.
