ORDER

As per the paper read as (1) above, the Principal, Christ College of Physical Education (Unaided), Irinjalakuda, Thrissur had applied for additional affiliation for starting M.P.E course for the academic year 2013-14 & 2014-15.

An Inspection Commission was constituted by the University to verify the facilities available in the College to teach the subjects and the Commission after Inspection on 23-03-2013 recommended for starting the new course of M.P.E in Christ College of Physical Education (Un-aided), Irinjalakuda, Thrissur during the Academic year 2013-14, vide paper read as (2) and the University recommended the same to the Government for consideration and concurrence.

Vide G.O. read (3) and (4) above, the Government of Kerala have granted Administrative Sanction and No Objection Certificate for starting the Self-financing/Unaided course of M.P.E with the intake of 24 students in Christ College of Physical Education (Un-aided), Irinjalakuda, Thrissur during the academic year 2013-14.

The Syndicate vide paper read as (5) above, has resolved to grant Provisional Affiliation to the new Self-financing course of MPE in Christ College of Physical Education (Un-aided), Irinjalakuda, Thrissur during the Academic year 2013-14.

An Undertaking to the effect that they will carry out faithfully the provisions of the University Act, Statues, Ordinances etc. in stamp paper worth ₹100/- attested by the Advocate Notary has also been submitted by the Principal and Manager of Christ College of Physical Education (Un-aided), Irinjalakuda, Thrissur.

The Principal of the college has remitted the required Administration and Affiliation fee of ₹60,000/- (Rupees

Sixty Thousand only) vide Challan Nos.147 & 146, dated 29-07-2013 at SBT, Feroke.

Sanction is, therefore, accorded for granting Provisional Affiliation for starting the Self-financing course of MPE at Christ College of Physical Education (Un-aided), Irinjalakuda, Thrissur for the academic year 2013-14 with an intake of 24 Students.

Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled.

In the light of the directions of the Supreme Court of India in WP(C)656/1998, the Institution shall take appropriate measures for the prevention of ragging in any form. In case of failure to prevent the instances appropriate action including withdrawal of affiliation of the college will be initiated.

Affiliation granted is strictly provisional and only for the academic year 2013-14. The College has to apply for continuation of affiliation for the ensuing years, remitting the fee fixed by the University.

Admission to the next academic year shall be made only after obtaining prior permission from the University.

Orders are issued accordingly.
