ORDER

The Principal, St.Mary's College, Thrissur vide reference (1) had submitted an application for starting new Self-financing courses of BSW, BBA, MCom and MSc Botany during the academic year 2013-14 & 2014-15.

An Inspection Committee was constituted to verify the infrastructure facilities available in the college to teach the subjects and the Commission after inspection on 20-03-2013 recommended the courses of BSW, BBA and M.Com with intakes of 24, 40 & 15 respectively in St.Mary's College, Thrissur during the academic year 2013-14 vide reference (2) above and the University recommended the same to the Government for consideration and concurrence.

Vide G.O.read (3) & (4) referred above, the Government have granted Administrative Sanction and NOC for starting the Self-financing courses of BSW, BBA and M.Com with intakes of 24, 40 and 15 respectively in St.Mary's College, Thrissur during the academic year 2013-14.

Considering the above, the Vice Chancellor, vide reference (5), has ordered to grant Provisional Affiliation for starting the above mentioned Self-financing courses in St.Mary's College, Thrissur for the academic year 2013-14 subject to ratification by the Syndicate.

An Undertaking to the effect that they will carry out faithfully the provisions of the University Act, Statutes, Ordinances etc in Stamp paper worth ₹ 100/- attested by the Advocate, Notary has also been submitted by the Principal and Manager of the College. The required Affiliation Fee of ₹ 20,000/- (Rupees Twenty Thousand only) has been remitted vide Challan Nos.77,78,79 & 81 dated 22-10-2012 at the Sub Treasury, Thrissur.

Sanction is therefore accorded for granting Additional Affiliation for the following new Self-financing/Un-aided courses in St.Mary's College, Thrissur for the academic year 2013-14, by the Hon.Vice Chancellor subject to the ratification by the Syndicate.

Selection and Admission to these courses shall be made only on the basis of the rules and regulation of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the Affiliation granted will automatically be cancelled.

In the light of the directions of the Supreme Court of India in WP(C) 656/1998, the Institution shall take appropriate action including withdrawal of the Affiliation of the College will be initiated.

Affiliation granted is strictly provisional and only for the academic year 2013-14. The College has to apply for Continuation of Provisional Affiliation for the ensuing years, remitting the fee fixed by the University.

Admission to the next academic year shall be made only after obtaining prior permission from the University.

Orders are issued accordingly.
