ORDER

On the basis of the recommendation of the University and the administrative sanction and NOC issued by the Govt., conditional affiliation was granted for obtaining approval from Bar Council of India for starting the new Self-Financing Law College, namely KMCT Law College in Malappuram District under the management of KMCT, Kozhikode for the academic year 2013-14, with LLB 5 year and LLB 3 year courses with an intake of 50 students each, subject to report to Syndicate, vide UO read first.

Vide letter read second, the Bar Council of India, granted temporary approval of affiliation to the Institution for imparting 3 year LLB and 5 year BBA LLB Law courses for a period of two years (2013-14 to 2014-15) with an intake of one section of 60 students in each course.

Vide reference read as third the KMCT has requested to grant affiliation to the three year LLB and five year BBA LLB courses at KMCT Law college, Mampara, Pazhur PO, Kuttippuram, Kerala with an intake of 60 each.

Considering the above, the Vice Chancellor has ordered to confirm the conditional affiliation granted to the KMCT Law college in Malappuram District for conducting BBA LLB 5 year and LLB 3 year courses and to grant provisional affiliation for the academic year 2013-14 with an intake of 50 students each.

Sanction has therefore been accorded to confirm the conditional affiliation granted to KMCT Law College in Malappuram District and to grant provisional affiliation for conducting BBA LLB(5 year) and LLB (3 year) courses with an intake of 50 students each in the academic year 2013-2014, subject to report to syndicate.

Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government by time to time, failing which the affiliation granted will automatically be cancelled.

In the light of the direction of the Supreme Court of India in WP(C) 656/1998 the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.

Affiliation granted is strictly provisional and only for the academic year 2013-14. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of the letter of extension of approval from the Bar Council of India.

Admission to the next academic year shall be made only after obtaining prior permission from the University and the Bar Council of India.

Orders are issued accordingly.
