ORDER

Sanction has been accorded by the Govt. for starting BA English programme in M.E.S Kalladi College,Mannarkkad,Palakkad during the academic year 2013-14 among the other programmes in the aided sector in Govt./Aided colleges affiliated to the Universities in Kerala as per Annexure-I of the G.O read as 1st.

As per U.O read as 2nd, the University granted permission/provisional affiliation for starting the aided course of BA English with an intake of 24 students in M.E.S Kalladi College, Mannarkkad, Palakkad for the academic year 2013-14,implementing the G.O dated 12.9.2013 as per the resolution of the Syndicate vide paper read as 3rd,subject to satisfactory completion of the following formalities and issuance of formal affiliation order:

Affiliation fee of ₹5,000/-(Rupees Five thousand only) for each course shall be remitted by each college and a notarised Undertaking to the effect that, they will carry out faithfully the provisions of the University Act, Statutes, Ordinance etc.,in stamp paper worth Rs.100/- signed by the Principal and the Manager of the colleges concerned shall be submitted and also an undertaking to the effect that, admission has not been made in the academic year 2013-14 in the cases of courses which have already been sanctioned under Self Financing mode. Affiliation order will be issued on receipt of the same.

As per the G.O dated 12.9.2013, it has been specified that if any course is allowed in the unaided sector and admission process to which has not been started during the academic year 2013-14 such courses alone shall be allowed to be started under aided sector by the concerned

Universities.

As per Letter read as 4th, the Principal, M.E.S Kalladi College, Mannarkkad, Palakkad requested to grant formal affiliation order in respect of BA English programme for the academic year 2014-15 remitting an amount of 5,000/- (Rupees Five thousand only) as affiliation fee vide chalan No.141125308 dated 29-05-2014 at SBT, University of Calicut. The Principal has also submitted a notarised Undertaking in stamp paper worth Rs.100/- duly signed by the Principal and the Manager of the college to the effect that they will faithfully carry out the provisions of the University Act, Statutes, Ordinances and Regulations and also stated that admission will not be done to BA English as self financial course during the academic year 2014-15.

Under the above circumstances, Sanction is accorded by the Vice Chancellor on 05-06-14, to grant Provisional/Formal affiliation for starting the aided programme BA English with an intake of 24 students in M.E.S Kalladi College, Mannarkkad, Palakkad for the academic year 2014-15 subject to the following conditions.

Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled.

Affiliation is strictly provisional and only for the academic year 2014-15. The college has to apply for Continuation of Provisional Affiliation for the ensuing years remitting the fee fixed by the University.

In the light of the directions of the Supreme Court of India in WP(C) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances, appropriate action including withdrawal of affiliation of the college will be initiated.

Orders are issued accordingly.
