ORDER

Vide paper read as (1) above, provisional affiliation was granted for starting the Post Graduate course of MA Malayalam in Self-financing mode with an intake of 15 Students in Vimala College, Thrissur during the academic year 2012-13.

The Principal vide paper read as (2) above, has mentioned that the Government of Kerala vide paper read as (3) above, in Annexure II dated 12-09-2013 has granted permission to start one course in the Aided sector in Vimala College, Thrissur.

As per the G.O.No.615/13/Hr.Edn.Dept, dated 12-09-2013, Para II, the Colleges in Annexure II, have to seek government concurrence to the Aided courses allotted to them after obtaining affiliation from the concerned Univesities. Vimala College, Thrissur is included in the list of Colleges in Annexure II of the G.O. dated 12-09-2013.

The Syndicate, vide paper read as (4) above, has resolved to implement the G.O.(Ms) No.615/13/H.Edn.Dept dated 12-09-2013, subject to the condition that the courses/syllabus are approved by concerned bodies and colleges create adequate infrastructure facilities. The Syndicate has also resolved to give 30 more days for the Colleges as a special case to start the course during this academic year and if the Management is not in a position to start the Course during this academic year, they may start the course during the next academic year.

The Government of Kerala vide paper read as (5) above, has sanctioned the Post Graduate course of MA Malayalam in Aided stream at Vimala College (Aided), Thrissur for the academic year 2013-14.

The Principal and the Manager of Vimala College, Thrissur has submitted necessary Notarised Undertaking in stamp paper worth Rs.100/- that the admission process to the Post Graduate Course of MA Malayalam with an intake of 15 students has not been done for the academic year. Necessary Affiliation Fee of Rs.5000/- (Rupees Five Thousand only) has been remitted by the Principal of the College vide Challan No.361 dated 28-9-2013 at SBI,Trichur.

Sanction is therefore accorded by the Hon.Vice Chancellor for granting Provisional Affiliation for starting the Post Graduate course of MA Malayalam in Aided mode at Vimala College (Aided), Thrissur, for the academic year 2013-14 with a sanctioned intake of 15 students.

Selection and Admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled.

Affiliation granted is strictly provisional and is only for the academic year 2013-14. The College has to apply for Continuation of Provisional Affiliation for the ensuing years remitting the fee fixed by the University.

In the light of the directions of the Supreme Court of India in WP (C) 656/1998, the Institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances, appropriate action including the withdrawal of affiliation of the college will be initiated.

Orders are issued accordingly.


