ORDER

The Govt., vide G.O read as 1st, have sanctioned new Govt. Arts & Science Colleges at Chelakkara, Thrissur (Dt) and Thrithala, Palakkad (Dt) for the academic year 2013-14. In the G.O it is specified that classes shall be conducted with Guest Lecturers till permanent teachers are appointed.

Vide G.O read as 2nd, the Govt. have sanctioned the following courses in the new colleges:

The Special Officers of the proposed Govt. Colleges at Chelakkara and Thrithala vide paper read as 3rd & 4th above, have submitted applications for the respective colleges for granting Affiliation to the new colleges.

As per the paper read as 5th above, Syndicate has resolved that the new Govt. Colleges sanctioned by the Govt. during this academic year be given provisional affiliation (as it is late) subject to receipt of Inspection Commission Reports. The New Govt. Colleges are permitted to start the admission procedures which shall be completed before 11-11-2013. Lost classes should be compensated by engaging extra classes and examination will not be postponed.

The Vice Chancellor, vide paper read as 6th above, has accorded sanction for Provisional Affiliation for starting the new Govt. colleges with initial intake for each programmes and taking steps for the Inspection at these colleges to suggest the requirements for compliance.

The Special Officers of the Government Colleges at Chelakkara and Thrithala have to remit the required Affiliation fee of Rs.2500/- (Rupees Two Thousand and Five Hundred only) per course to the University account for the academic year of 2013-14.

Provisional affiliation is, therefore, granted for starting the new Government Colleges at Chelakkara and Thrithala with the name and style of Govt. Arts and Science College, Chelakkara, Thrissur and Govt. Arts and Science College, Thrithala, Palakkad for the academic year 2013-14 with the following courses and intake noted against each.

Selection and Admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the Affiliation granted will automatically be cancelled.

Affiliation granted is strictly provisional and only for the academic year 2013-14. The College has to apply for Continuation of Provisional Affiliation for the ensuing years remitting the fee fixed by the University.

In the light of the directions of the Supreme Court of India in WP(C) 656/1998, the Institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances, appropriate actions including withdrawal of affiliation of the colleges will be initiated.
