ORDER

The Principal, St.Aloysius College (Aided), Elthuruth, Thrissur had applied for Provisional Affiliation for starting the Post Graduate course of M Sc Mathematics for the academic year 2013-14 vide paper read as 1st.

The District Level Inspection Commission conducted inspection at the College on 20-03-2013 and recommended to start the course with an intake of 12 students vide paper read as 2nd and the University forwarded the same to the Government for consideration and concurrence.

After having obtained the Administrative Sanction and NOC from the Govt., provisional Affiliation was granted for starting the Post Graduate course of MSc Mathematics in Self-financing mode at St.Aloysius College (Aided), Elthuruth, Thrissur during the academic year 2013-14 vide U.O No.3799/2013/CU dated 07-09-2013.

As per the paper read as (3) above, the Government of Kerala has granted sanction to start the Post Graduate course of MSc Mathematics programme in Aided stream in St.Aloysius College (Aided), Thrissur for the academic year 2013-14.

Vide paper read as (4), the Syndicate resolved to implement the G.O.(Ms) No.615/13/H.Edn.Dept

dated 12-09-2013, subject to the condition that the courses/syllabus are approved by concerned bodies and colleges create adequate infrastructure facilities. The Syndicate has also resolved to give 30 more days for the Colleges as a special case to start the course during this academic year and if the Management is not in a position to start the Course during this academic year, they may start the course during the next academic year.

Vide paper read as (5) above, the Higher Education Department of Govt. of Kerala has granted sanction order to start the new Aided course of MSc Mathematics at St. Aloysius College, Elthuruth, Thrissur.

Vide paper read as (6) above, the Principal, St. Aloysius College (Aided), Elthuruth, Thrissur has requested to grant Affiliation for starting M.Sc Mathematics (Aided) for the academic year 2013-14 as the admission procedures to the course has not yet started at the College.

The Principal and Manager of the College has submitted a Notarised Undertaking in Stamp paper worth Rs.100/- stating that they have not made admission for starting the M.Sc. Mathematics course already sanctioned in self financing mode during the academic year and they will carry out faithfully the provisions of the University Act, Statutes, Ordinances etc. The required Affiliation fee of Rs.5000/- (Five Thousand only) has been remitted vide Challan No.1371159 dated 30-10-2013 University Challan Counter, Thenjipalam.

Sanction is therefore accorded for granting Additional Affiliation for starting MSc Mathematics (Aided) programme at St. Aloysius College (Aided), Elthuruth, Thrissur for the academic year 2013-14 with an intake of 12 students.

Selection and Admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the Affiliation granted will automatically be cancelled.

Affiliation granted is strictly provisional and only for the academic year 2013-14. The Principal, St. Aloysius College (Aided), Elthuruth, Thrissur has to apply for Continuation of Provisional Affiliation of the course for the ensuing years, remitting the fee fixed by the University.

In the light of the directions of the Supreme Court of India in WP (C) 656/1998, the Institution should take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances, appropriate action including withdrawal of affiliation of the college will be initiated.

Orders are issued accordingly.


