ORDER

The Principal, Sri Vyasa NSS College, Vyasagiri, Wadakkanchery, Thrissur, vide paper read as (1) above, had applied for starting the Post Graduate course of M.Sc.Mathematics for the academic year 2013-14 & 2014-15.

The District Level Inspection Commission appointed by the University, after conducting inspection at the College, recommended to start the Post Graduate course of MSc Mathematics with an intake of 12 students vide paper read as (2) above, and the University forwarded the same to the Government for consideration and concurrence.

As per paper read as (3) above, the Government of Kerala has sanctioned 1 course (in Annexure II of the order) in the college without specifying the name of the course. In the G.O it has been specified that in the case of courses listed in Annexure II, the Govt. shall issue separate orders on getting approval from the concerned Universities.

As per paper read as (4) above, the Syndicate has considered the matter of granting provisional affiliation for the new aided courses sanctioned by the Government for the affiliated colleges as per G.O (MS) No. 615/13/H.Edn.Department dated 12.09.2013 and resolved to implement G.O. (MS) No.615/13/H.Edn.Dept. dated 12.09.2013, subject to the condition that the courses / syllabus are

approved by concerned bodies and the colleges create adequate infrastructure facilities. It has also resolved to give 30 more days for the colleges as a special case to start the courses during this academic year and if the management is not in a position to start the course during this academic year, they may start the course during next academic year.

In view of the recommendation from the University, the Government of Kerala has sanctioned M.Sc.Mathematics course in Aided stream in Sri Vyasa NSS College (Aided), Vyasagiri, Wadakkanchery, Thrissur. for the academic year 2013-14 vide paper read as (5) above.

Vide paper read as (6) above, the Principal, Sri Vyasa NSS College (Aided), Vyasagiri, Wadakkanchery, Thrissur has requested to grant Provisional Affiliation for starting the Post Graduate course of MSc Mathematics in Aided stream for the academic year 2013-14. The Principal and Manager of the College has submitted a Notarised Undertaking in Stamp paper worth Rs.100/- stating that they will carry out faithfully the provisions of the University, Act, Statutes, Ordinances etc. The required affiliation Fee of Rs.5,000/- (Rupees Five Thousand only) has been remitted vide Challan No. 1357908 dated 01-10-2013 at University Challan Counter.

Sanction is therefore accorded for granting Provisional/Formal Affiliation for starting the Post Graduate course of MSc Mathematics (Aided) with an intake of 12 students at Sri Vyasa NSS College (Aided), Vyasagiri, Wadakkanchery, Thrissur, for the academic year 2013-14.

Selection and Admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the Affiliation granted will automatically be cancelled.

Affiliation granted is strictly provisional and only for the academic year 2013-14. The Principal, Sri Vyasa NSS College (Aided), Vyasagiri, Wadakkanchery, Thrissur has to apply for the Continuation of Provisional Affiliation of the course for the ensuing years, remitting the fee fixed by the University.

In the light of the directions of the Supreme Court of India in WP (C)656/1998, the Institution should take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances, appropriate action including withdrawal of affiliation of the college will be initiated.

Orders are issued accordingly.


