ORDER

The Principal, St.Joseph's College, Irinjalakuda, Thrissur, vide paper read as (1) above, had submitted application for starting of MA Malayalam course during the academic year 2013-14 & 2014-15.

An Inspection Commission was constituted to verify the facilities available in the college to teach the subjects and the Commission after inspection recommended the MA Malayalam course with an intake of 15 students in St. Joseph's College, Irinjalakuda, Thrissur during the academic year 2013-14 vide reference (2) above and the University recommended the same to the Government for consideration and concurrence.

University of Calicut vide UO read as (3) has granted Provisional Affiliation to start the Post Graduate course of MA Malayalam with an intake of 15 Students in Self-financing mode at St. Joseph's College, Irinjalakuda, Thrissur during the academic year 2013-14.

As per paper read as (4), the Government of Kerala have sanctioned 1 course (in Annexure II of the order) in the college without specifying the name of the course. In the G.O it has been specified

that in the case of courses listed in Annexure II, the Govt. shall issue separate orders on getting approval from the concerned Universities.

As per paper read as (5) above, the Syndicate has considered the matter of granting provisional affiliation for the new aided courses sanctioned by the Government for the affiliated colleges as per G.O (MS) No. 615/13/H.Edn.Department dated 12.09.2013 and resolved to implement G.O. (MS) No.615/13/H.Edn.Dept. dated 12.09.2013, subject to the condition that the courses/syllabus are approved by concerned bodies and the colleges create adequate infrastructure facilities. It has also resolved to give 30 more days for the colleges as a special case to start the courses during this academic year and if the management is not in a position to start the course during this academic year, they may start the course during next academic year.

In view of the recommendation from the University, the Government of Kerala has sanctioned MA Malayalam course in Aided stream with an intake of 15 students in St. Joseph's College, Irinjalakuda Thrissur for the academic year 2013-14 vide paper read as (6) above.

Vide paper read as (7), the Principal, St. Joseph's College, Irinjalakuda, Thrissur has requested to grant Provisional Affiliation for starting the Post Graduate course of MA Malayalam in Aided stream for the academic year 2013-14.

The Principal and Manager of the College has submitted a Notarised Undertaking in stamp paper worth Rs.100/- stating that they will carry out faithfully the provisions of the University Act, Statutes, Ordinances etc. and stated that the admission process for the first semester of MA Malayalam for 2013-14 has not been started yet. The required affiliation Fee of Rs.5,000/- (Rupees Five Thousand only) has been remitted vide Challan No. 1378505 dated 13-11-2013 at University Challan Counter.

Sanction is, therefore, accorded for granting Provisional Affiliation for starting the Post graduate course of MA Malayalam in aided stream with an intake of 15 students at St. Joseph's College, Irinjalakuda, Thrissur, for the academic year 2013-14. Hon.Vice Chancellor has granted extension for admission to the Post Graduate course of MA Malayalam (Aided) up to 30-11-2013.

Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled.

In the light of the directions of the Supreme Court of India in WP(C) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances appropriate action including withdrawal of affiliation of the college will be initiated.

Affiliation granted is strictly provisional and only for the academic year 2013-14. The College has to apply for continuation of provisional affiliation for the ensuing years, remitting the fee fixed by the

University. Admission to the next academic year shall be made only after obtaining prior permission from the University.
