**ORDER**

The Principal,St.Mary's College (Aided),Thrissur had applied for Provisional Affiliation for starting the Post Graduate course of M.Com for the academic year 2013-14 vide paper read as 1.

The District Level Inspection Commission conducted Inspection at the College and recommended to start the course with an intake of 15 students vide paper read as 2 and the University forwarded the same to the Government for consideration and concurrence.

After having obtained the Administrative Sanction and NOC from the Government, provisional affiliation was granted for starting the Post Graduate course of M.Com with an intake of 15 students in Self-financing mode for the during the academic year 2013-14 vide UO read as 3.

Government of Kerala vide paper read as 4 has granted sanction to start the Post Graduate course of M.Com in Aided stream with an intake of 15 students at St.Mary's College (Aided),Thrissur during the academic year 2013-14.

Vide paper read as (5) above, the Syndicate has resolved to implement the G.O.(Ms) No.615/13/H.Edn.Dept dated 12-09-2013, subject to the condition that the courses/syllabus are approved by concerned bodies and colleges create adequate infrastructure facilities. The Syndicate has also resolved to give 30 more days for the colleges as a special case to start the course during this academic year and if the Management is not in a position to start the course

during this academic year, they may start the course during the next academic year.

University of Calicut vide UO read as 6th, has granted sanction to start the Post Graduate course of M.Com in Aided stream with an intake of 15 students at St.Mary's College, Thrissur during the academic year 2013-14.

Vide paper read as 7th, the Principal, St.mary's College, Thrissur has requested to grant affiliation for starting the Aided course of M.Com with an intake of 15 students at the college during the academic year 2013-14.

The Principal of the College has remitted an amount of Rs.5000/- (Five Thousand only) to University as Affiliation fee for the PG course of M.Com in Aided stream at the College vide Challan No.65 dated 25-10-2013 and submitted notarised Undertaking in Stamp paper worth Rs.100/- to the effect that they will carry out faithfully the provisions of the University Act, Statutes, Ordinances etc. An Undertaking has also been submitted by the Principal and the Manager that admission process to the M.Com course granted in Unaided stream in the academic year 2013-14 has not been started.

Sanction is therefore accorded for granting Provisional Affiliation for starting the Post Graduate course of M.Com in Aided stream at St.Mary's College (Aided), Thrissur, during the academic year 2013-14 with a sanctioned intake of 15 students.

Selection and Admission to these courses shall be made only on the basis of the rules and regulation of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the Affiliation granted will automatically be cancelled.

In the light of the directions of the Supreme Court of India in WP(C) 656/1998, the Institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances, appropriate action including withdrawal of affiliation of the College will be initiated.

Affiliation granted is strictly provisional and only for the academic year 2013-14. The College has to apply for Continuation of Provisional Affiliation for the ensuing years, remitting the fee fixed by the University.

Admission to the next academic year shall be made only after obtaining prior permission from the University.

Orders are issued accordingly.


