**ORDER**

The Principal, M.E.S. Asmabi College, P.Vemballur, Thrissur had applied for Provisional Affiliation for starting the Post Graduate course of MA Economics for the academic year 2013-14 and 2014-15 vide paper read as (1) above.

Accordingly, the University appointed a District Level Inspection Commission to verify the facilities available in the college and the Inspection Commission vide paper read as (2) above, recommended the Post Graduate course of MA Economics with an intake of 15 Students at the College and the University forwarded the same to the Government for consideration and concurrence.

After having obtained the Administrative Sanction and NOC from the Government, Provisional Affiliation was granted for starting the Post Graduate course of MA Economics in Self-financing mode at M.E.S.Asmabi College, P.Vemballur, Thrissur during the academic year 2013-14 vide paper read as (3) above.

Vide paper read as (4) above, the Government of Kerala has granted sanction to start the Post Graduate course of MA Economics in Aided stream in M.E.S.Asmbi College, P.Vemballur, Thrissur during the academic year 2013-14.

Vide paper read as (5), the Syndicate has resolved to implement the G.O.(Ms) No.615/13/H.Edn.Dept dated 12-09-2013, subject to the condition that the courses/syllabus are approved by concerned bodies and the colleges create adequate infrastructure facilities. The Syndicate has also resolved to give 30 more days for the Colleges as a special case to start the course during this academic year and if the Management is not in a position to start the Course during this academic year, they may start the course during the next academic year.

University of Calicut vide UO read as (6) above, has granted permission to start the Post Graduate course of MA Economics in Aided stream with an intake of 15 Students at the college during the academic year 2013-14, subject to issuance of affiliation order on satisfactory completion of all the formalities.

Vide paper read as (7) above, the Principal, M.E.S. Asmbi College Aided), P.Vemballur, Kodungallur, Thrissur has requested to grant Affiliation for starting MA Economics (Aided) for the academic year 2013-14. He has also submitted a copy of the G.O.dated 12-09-2013 sanctioning the course from the Government.

The Principal and Manager of the College has submitted a notarised Undertaking to the effect that they will carry out faithfully the provisions of the University Act, Statutes, Ordinances etc. in Stamp paper worth Rs.100/- The required Affiliation fee of Rs.5000/- (Five Thousand only) has been remitted vide Challan No.233 dated 13-11-2013 at SBI,Kodungallur.

The Principal, M.E.S Asmbi College, P.Vemballur has informed that the College has not started the admission procedures to the Post Graduate course of MA Economics granted in Self-financing mode by the University for the current academic year 2013-14.

As per G.O.(Ms) No.615/13/H.Edn.Dept dated 12-09-2013, the aided course will be sanctioned only if admission is not made to the course for the academic year 2013-14 under unaided sector.

Sanction is therefore accorded for granting Provisional Affiliation for starting Post Graduate course of MA Economics programme in Aided stream at M.E.S. Asmbi College (Aided), P.Vemballur, Kodungallur, Thrissur with an intake of 15 students for the academic year 2013-14.

Selection and Admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the Affiliation granted will automatically be cancelled.

Affiliation granted is strictly provisional and only for the academic year 2013-14. The College has to apply for Continuation of Provisional Affiliation for the ensuing years remitting the fee fixed by

the University.

In the light of the directions of the Supreme Court of India in WP (C) 656/1998, the Institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances, appropriate action including withdrawal of affiliation of the college will be initiated.

Orders are issued accordingly.


