ORDER

Provisional affiliation was granted for starting MBA programme in Holy Grace Academy of Management Studies, Kuruvilassery, Mala, Thrissur during the academic year 2005-2006 with an intake of 60 students vide University Order read as first.

Increase of intake has been granted to the MBA programme in the college from 60 to 120 with effect from the academic year 2011-12 with permission to admit students during the academic year 2012-13 vide U.O read as second.

Continuation of provisional affiliation was granted to the programme upto the academic year 2012-13 vide U.O read as third.

The Principal, Holy Grace Academy of Management Studies, Kuruvilassery, Mala, Thrissur, as per letter read as fourth, has requested to grant continuation of provisional affiliation to the MBA programme in the college for the academic year 2013-14 remitting an amount of Rs.1,10,000/- (Rupees One Lakh and ten thousand only) towards administration and affiliation fee vide chalan No.58236 dated 2.5.2013 at Janasevanakendram, Thrissur.

The All India Council for Technical Education, vide letter read as fifth, has extended its approval to the MBA programme in the college upto the academic year 2013-14 with an intake of 120 students.

Academy of Management Studies, Kuruvilassery, Mala, Thrissur for the academic year 2013-14 with an intake of 120 students.

Selection and admission shall be made only on the basis of the rules and regulations of the University and Government and on the basis of the directions issued from time to time, failing which the affiliation granted will automatically be cancelled.

In the light of the directions of the Supreme Court of India in WP (C) 656/1998, the institutions shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances, appropriate action including withdrawal of affiliation of the college will be initiated.

Affiliation granted is strictly provisional and only for the academic year 2013-14 and the college has to apply for continuation of provisional affiliation to the programme for the ensuing years, remitting the fee fixed by the University along with a copy of the Extension of Approval Order from the All India Council for Technical Education.

Orders are issued accordingly.
