ORDER

Vide paper read as(1) above, the Government of Kerala have granted Administrative Sanction for starting new UG course of BA English in N.S.S College,Nemmara,Palakkad.The Principal requested for the conversion for the already sanctioned BA English course to BA Malayalam.

The District Level Inspection Commission, vide paper read as(2), has conducted inspection at the college on 28.02.2014 and recommended to start the course BA Malayalam with an intake of 24 students.

The Government, vide paper read as(3), have granted NOC for starting the aided course of B.A Malayalam(24 seats)in lieu of BA English in NSS College,Nemmara,Palakkad during the academic year 2014-15.

The Principal,N.S.S College,Nemmara,Palakkad had applied for starting new course of BA Malayalam for the academic year 2014-15 as per paper read as(4).An amount of ₹ 5000/- was remitted as Affiliation fee for BA Malayalam course vide Chalan No.1491033 dt.20.06.2014 at University Chalan Counter.The Principal and the Manager of N.S.S College,Nemmara,Palakkad has submitted a Notarised Undertaking in stamp paper worth ₹ 100/- duly signed by the Principal and the Manager of the College.

The Syndicate, vide paper read as(5),which approved the question of starting new courses in the existing colleges for the academic year 2014-15 and also authorized the Vice Chancellor to take appropriate decisions in this regard.

Under the above circumstances, Sanction is accorded by the Vice Chancellor on 06-07-14, to grant Provisional Affiliation for starting new course of BA Malayalam with an intake of 24 students in NSS College, Nemmara, Palakkad during the academic year 2014-15 subject to the following conditions.

Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled.

Affiliation is strictly provisional and only for the academic year 2014-15. The college has to apply for Continuation of Provisional Affiliation for the ensuing years remitting the fee fixed by the University.

In the light of the directions of the Supreme Court of India in WP(C) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances, appropriate action including withdrawal of affiliation of the college will be initiated.
