ORDER

The Principal, Ansar Arabic College, Valavannur, Malappuram had applied for additional affiliation for MA Post Afzal Ul Ulama degree programme in the college as per the application read as first above.

As per the letter read as second, MA Post Afzal Ul Ulama degree programme was recommended and forwarded for the consideration and concurrence of the Government of Kerala.

As per the GO read as 3rd the Government of Kerala have sanctioned the MA Post Afzal Ul Ulama degree programme in Aided stream to the College for the academic year 2013-2014.

As per the GO (Ms) No. 615/13/HEdn dated 12.9.2013, the Govt of Kerala have sanctioned new courses in aided stream with the condition that the University should sanction the course in Aided stream, only if the admission process has not started/classes are not started for the sanctioned Courses in the unaided stream.

As per the syndicate resolution item no. 2013.985 dated 20.9.2013, the syndicate has resolved to implement GO (Ms) No. 615/13/HEdn dated 12.9.2013 subject to the condition that the courses/syllabus are approved by the concerned bodies and all the colleges create adequate infrastructure facilities. It is also resolved to give 30 more days for the colleges as a special case to start the courses during this academic year.

As per the syndicate resolution item no. 2013.1059 dated 20.9.2013 the syndicate has approved the

question of granting affiliation to the newly sanctioned courses by the Government of Kerala as per the GO (Ms) No.615/13/HEdn dated 12.9.2013 for the academic year 2013-2014 in all government and government aided colleges with verification if necessary.

As per the U O No.4648/2013/CU dated 9.10.2013, the G O (Ms) No.615/13/HEdn dated 12.9.2013 was implemented with many terms and conditions which is to be strictly followed by the College in all respects.

Permission was granted as per U O No. 4648/2013/CU dated 9.10.2013 for starting the aided course of MA Post Afsal-Ul-Ulama (20 seats) in the Ansar Arabic College, Valavannur for the academic year 2013-14 as sanctioned by the Government along with other colleges and courses, subject to issuance of formal affiliation order by the University, on satisfactory completion of all the formalities.

In the Note of the V C dated 7.10.2013, it is specified that conversion of students admitted in unaided courses to the aided courses will not be permitted in any case and if any of the courses are allowed in the unaided sector and admission process to which has not been made during the academic year such courses alone will be allowed to start under the aided sector.

The College has submitted an undertaking to the effect that this course has not been offered by the institution earlier in the aided or unaided mode.

The Principal and Manager, Ansar Arabic College, Valavannur, Malappuram have submitted an undertaking to the effect that the college shall carry out faithfully the provisions of the University Act, Statutes, Ordinances, and Regulations and directions issued by the University from time to time and admit only such students who are eligible as per the regulations of the University. They have also agreed that the University can proceed with strict actions including withdrawal of affiliation of the college, if anything is done by them, against the interest of the University or the student community.

An amount of ₹ 5000 has been remitted by the college towards affiliation fee as per the Chalan No. 405 dated 29/10/13 at Sub Treasury, Tirur.

Considering the above, sanction is accorded by the Vice Chancellor for granting provisional affiliation for starting MA Post Afsal Ul Ulema degree programme in aided stream with an intake of 20 seats in Ansar Arabic College(Aided), Valavannur, Malappuram for the academic year 2013-2014.

Selection and admission shall be made only on the basis of the Rules and Regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled.

In the light of the direction of the Supreme Court of India in W P © 656/1998, the institution shall take appropriate measures for the prevention of ragging in any form. In case of failure to prevent such instances appropriate action including withdrawal of affiliation of the college will be initiated.

Affiliation granted is strictly provisional and only for the academic year 2013-2014. The College has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University. Admission to the next academic year shall be made, only after obtaining prior permission from the University.

Orders are issued accordingly.
