ORDER

As per the provisions mentioned in the University order read as Ist paper above, orders were issued for the award of Grace Marks to the outstanding sportsmen/women of the University, at their first appearance of the Annual Examination of the year of representation/participation in the Tournaments.

2. In the representation read as 2nd paper above, Kumari Rajitha.K.V. who could not attend the April 1997 Second BSc degree examination of the University due to her participation in the IV National Games (Hand Ball) held at Bangalore under the auspices of the Karnataka Olympic Association and appeared for the II BSc degree examination held in October 1997, requested the University for the award of Sports grace marks admissible to her for her participation in IV National Games, at the subsequent examination.

3. The Academic Council at its meeting held on 27.8.1998 vide item No. 1: 10 considered the question of award of grace marks to those candidates who could not appear for the University examinations solely due to their participation in sports competitions and resolved to grant grace marks to such sports stars at their next chance irrespective of annual/supplementary examination.

4. Sanction is therefore accorded for the award of grace marks, irrespective of Annual or Supplementary appearance, to those candidates who could not appear for the University examinations solely due to their participation in the sports and games coaching camps/events at their next chance. The dates of participation should be certified by the Authority organizing such events /camps and countersigned by the Director of Physical Education, Calicut University.
