**ORDER**

The Secretary, Association of college Teachers in Physical Education (under Calicut University), vide letter read as (3) above has forwarded the revised norms for admission to Degree and Post Graduate courses under Sports Quota and additional seats under Sports Quota and requested to accept the norms and implement the same.

As per the Orders of Vice-chancellor, the norms furnished by the Secretary was forwarded to the Assistant Director, Department of Physical Education, University of Calicut to submit a proposal after examining the present practice and improvements suggested.

The Assistant Director, vide his letter read as (4) above, has submitted the proposal for revision of norms for admission to Degree and Post Graduate courses under sports quota and additional seats under sports quota.

The Syndicate at its meeting held on 22.02.2003, vide item No. 2003.134, considered the question of revision of norms for admission under Sports Quota and additional seats under Sports Quota for Degree and Post Graduate courses and resolved that the courses committee shall examine the matter.

The Standing Committee on affiliation of Colleges and Courses held on 2.05.2003, vide item No. 1 considered the proposal submitted by the Assistant Director, Department of Physical Education and resolved as follows:-

1. To recommend the deletion of item No. 4,6 & 13 from the norms for sports quota for admission to Degree course as plus 2 students do not have participation in any of the University competitions.
2. to recommend all the norms for admission to Post Graduate Degree Course (item 1 to 12).
3. to recommend the deletion of item 4.6 and 13 under the norms for sports quota for creation of additional seat in Degree course, as plus 2 students do not have participation in any of the University competitions.
4. To recommend the norms for Sports Quota for additional seats in Post Graduate course (item 1 to 5)

The Syndicate at its meeting held on 21.06.2003, vide item No. 2003.337, considered the recommendations of the Standing Committee on Affiliation and courses regarding the revision of norms for admission under Sports Quota and additional seats under Sports Quota for Degree and Post Graduate courses and resolved to approve the recommendations except the following items under each title.

Proposal for Sports Quota for norms for admission to Degree Courses, submitted by Assistant Director, Department of Physical Education.

Proposal for Sports Quota norms for additional seats for degree courses submitted by Assistant Director, Department of Physical Education.

Sanction has therefore been accorded to implement the revised norms for admission in the seats reserved under Sports Quota for Degree courses and in the additional seats under Sports Quota for Degree and Post Graduate courses.
