ORDER

A meeting of the representatives of teachers of Physical Education was held at the Department of Physical Education on 06.06.2013 to discuss various matters related to the conduct of Inter Collegiate and Inter University Tournaments. The meeting has decided to submit some proposals regarding the conduct of various tournaments and allied matters. The above meeting also resolved to submit the proposals before the Monitoring Committee for the working of the Department of Physical Education, for consideration.

As per the proposals submitted by the above meeting, the Monitoring Committee for the working of the Department of Physical Education considered the following proposals along with other proposals :

1. To conduct the Inter Collegiate Archery Championships as per AIU guidelines by including Compound round and Olympic round in individual and team championships
2. To conduct Zonal and Inter Zonal Cricket tournament by adopting inner circle rule as being followed in the All India Inter University tournaments
3. To select four teams from each zone to participate in the Inter Zonal tournament and to conduct women section zonal tournament as followed in the men section.
4. To include two judges from other districts for Kalaripayattu and Yoga Inter Collegiate Tournaments while selecting five judges without increasing the numbers and to fix up the Break up point of judges in kalaripayattu Championships into 0.05.
5. To consider honouring the Gold/Silver medal winners in the Inter Collegiate tournaments at the venue itself.
6. To consider the question of issuing certificates for Inter College level competitions for the first three places and its details to be sent to the University by zonal conveners and at the same time they are not eligible for grace marks
7. To fix the criteria for selecting the three best colleges in sports as detailed below:
 - A. I, II & III winners of Inter Collegiate team games will be awarded 10, 6 & 2 points.
 - B. Individual 1 st place winners will be awarded 1 point.
 - C. Champions, II & III position of aggregate championships will be awarded 5, 3 & 1 points. In those events of aggregate championships where there is more than one player/Athlet 2 point will be awarded to winning pair

/ team.

8.To amend the Handbook of the Department of Physical Education with respect to the number of members in the Zonal Protest Committee. The Inter Collegiate Inter Zonal protest committee is to be reconstituted as given below:

I. Head of the Department of Physical Education, Calicut University (Chairman)

II. Assistant Director of Physical Education (Member)

III. Four Zonal Conveners (Members)

IV If protest is lodged by a member of the protest Committee then the HOD/DPE shall nominate a senior member of that zone to the Committee.

9.To permit the Director of Physical Education to appoint Match Commissioner for various Inter Collegiate tournaments

The Monitoring Committee for the working of the Department of Physical Education approved the proposals noted above as 1,2,3 , 4, 7 and 8.

Regarding the proposal (5 above) to consider honouring the Gold/Silver medal winners in the Inter Collegiate tournaments at the venue itself, Monitoring Committee for the working of the Department of Physical Education deferred the item for detailed study by Dr. K.P.Manoj, Asst. Director, Department of Physical Education.

With regard to the proposal noted above as 3, the Monitoring Committee for the working of the Department of Physical Education resolved to select four teams from each zone to participate in the Inter Zonal tournament and to conduct zonal tournament in Badminton Shuttle for women as followed in the men section.

With regard to proposal noted above as 6, the Monitoring Committee for the working of the Department of Physical Education resolved to defer the matter for detailed study by the Deputy Director in charge of the Director and the Zonal Convenor.

Against the proposal to appoint match commissioner, the Monitoring Committee for the working of the Department of Physical Education resolved to authorise the Assistant Director, DPE to appoint match commissioner in consultation with the Director, DPE.

The Syndicate on 21.03.2015 vide item No. 2015.382* has considered the minutes of the Monitoring Committee for the working of the Department of Physical Education and resolved to approve the resolutions.

The Vice-Chancellor, vide order dated 27.03.2015 has granted permission to implement the resolution of the Syndicate.

Orders are issued implementing the decisions of the Syndicate.
