The Choice based Credit Semester System for UG Programmes under School of Distance Education has been implemented with effect from 2011 admission under University of Calicut.As per paper read as (1) above.

The Modified Regulations of Choice based Credit Semester System for UG Programmes under School of Distance Education was implemented with effect from 2011 admission under University of Calicut, as per paper read as (2) above.

The Steering Committee on Choice based Credit Semester System (UG), as per paper read as (3) above, has resolved to make certain amendments in the existing Regulations of Choice based Credit Semester System under School of Distance Education w.e.f 2011 admissions as detailed below

4.13: Change of Common and Complementary Courses under CCSS UG School of Distance Education, is permitted as follows:

- a) B.Com/BBA – up to and before 3rd Semester.
- b) Other UG programmes – up to and before 5th Semester.
- c)Change of Specialization of B.Com and BBA Programmes(such as Computer Application,Co-Operation) is permitted before 5th Semester Registration.

Change of Core Courses is permitted up to and before 3rd Semester. For changing Core Course, the candidate has to cancel all the examinations taken in the Core Course. However the marks/grade obtained in the Common and Complementary Courses (if it is the same with regards to the changed Core) shall be retained. Open Courses cannot be changed.

The Vice-Chancellor, considering the exigency, exercising the powers of the Academic Council, approved the minutes of the Steering Committee on CCSS UG, subject to ratification by the Academic Council. Sanction has therefore been accorded for amending the existing Regulations of CCSS UG (SDE) w.e.f 2011 admissions as follows:

4.13: Change of Common and Complementary Courses under CCSS UG School of Distance Education, is permitted as follows:

- a) B.Com/BBA – up to and before 3rd Semester.
- b) Other UG programmes – up to and before 5th Semester.
- c) Change of Specialization of B.Com and BBA Programmes (such as Computer Application, Co-Operation) is permitted before 5th Semester Registration.

Change of Core Courses is permitted up to and before 3rd Semester. For changing Core Course, the candidate has to cancel all the examinations taken in the Core Course. However the marks/grade obtained in the Common and Complementary Courses (if it is the same with regards to the changed Core) shall be retained. Open Courses cannot be changed.

4: PROGRAMME STRUCTURE

4.6 : There will be **no Project Work** during V Semester (2013-14) as detailed in the Syllabus. Instead, an additional Course (based on the Core Course) will be offered, the examination of which will be conducted in the VI Semester (for 2011-12 CCSS SDE admission)

4.8: The number of Open Courses has been limited to 10 numbers under SDE

4.11: Award of Degree for Additional Degree: For additional degree to those candidates who possess a degree under any programme in CCSS, the students have to write Core Course (within the Faculty), Complementary Course (if it is different) and Open Course for obtaining additional degree. A candidate possessing a degree in the yearly pattern can not apply for a additional degree in the CCSS pattern. Such students (with degree under yearly pattern) should appear afresh for all courses including common, core, complementary and open courses.
