**ORDER**

The Provisional Affiliation for starting MA English course at Cherpulassery College of Science and Technology for Women, Karalmanna, Palakkad during the academic year 2014-15 was granted vide U.O. read as first above.

The above course was suspended during the academic year 2014-15 with permission to restart the course during the academic year 2015-16 vide U.O. read as second above.

The Principal, Cherpulassery College of Science and Technology for Women, Karalmanna, Palakkad has applied for Continuation of Provisional Affiliation to M.A English course for the academic year 2015-16 vide letter read as third above.

An Inspection Commission was appointed to consider Continuation of Provisional Affiliation to M.A. English course for the academic year 2015-16. The Inspection Commission has informed that the college had no admissions to M.A English course and hence inspection at the college will be infructuous.

The Principal, Cherpulassery College of Science and Technology for Women, Karalmanna, Palakkad vide letter read as fourth above, has requested to disaffiliate M.A. English from the academic year 2016-17 and remitted an amount of Rs. 30,000/- (Rupees Thirty Thousand Only) towards disaffiliation fee vide chalan no. 152078299 dated 10.02.2016.

As per Calicut University First Statute, 1977, Chapter 23, Clause 15(b), No course of study shall be abolished in any College without the prior approval of the Syndicate.

The Syndicate, vide paper read as fifth above, has considered the matter of disaffiliation of M.A.

English course at Cherpulassery College of Science and Technology for Women, Karalmanna, Palakkad from the academic year 2016-17 onwards and has approved the same as per rules.

Sanction has, therefore, been accorded by the Hon'ble Vice Chancellor on 28.04.2016 to implement the Syndicate resolution for disaffiliation of M.A. English course at Cherpulassery College of Science and Technology for women with effect from the academic year 2016-17.

Therefore, M.A. English course with an intake of 20 students at Cherpulassery College of Science and Technology for women, Karalmanna, Palakkad is disaffiliated with effect from the academic year 2016-17.
