ORDER

Vide University Order referred to 1st above, it was stated in the foot note that "no remuneration to the office staff engaged in regular examination duty in University Departments and Centres" for the conduct of examination. Hence, vide reference cited 2nd above, the Finance Branch requested to clarify whether the faculty members, technical staff and non teaching staff in the University Departments, Centres and IET, Kohinoor come under the purview of the term Office Staff as far as regular exam duty is concerned.

The matter was placed before the Standing Committee of the Syndicate on Examinations held on 19/03/2015 and as per reference cited 3rd above, the SC on Examinations vide item No. 24 resolved to place the same in the Syndicate for consideration.

As per reference cited 4th above, the Syndicate held on 06/06/2015 vide item No. 2015.611 deferred the same for detailed study by the Standing Committee on Staff and Finance.

Vide reference cited 5th above, the Syndicate held on 01/08/2016 vide item No. 2016.777* resolved that the permanent non-teaching staff, faculty members and technical staff in the University Departments, Centres and IET, Kohinoor be considered as Office Staff.

Sanction has therefore been accorded by the Hon'ble Vice Chancellor as per paper read as 6th above, to implement the Syndicate decision.
