ORDER

Vide paper read as (1), B.Com Degree holders under CCSS-UG pattern of Calicut University is permitted to write additional specialization courses under CCSS-UG pattern after a lapse of one year subsequent to their passing of B.Com Degree Examination, after obtaining private registration.

Vide paper read as (2) Steering Committee on CUCBCSS UG-2014 resolved that B.Com additional specialisation candiates have to register in the Vth semester and apply for specialisation papers through SDE in Vth semester, when it is notified.

Academic Council, vide Item No.19 at its meeting held on 11.07.2015 approved the resolution of the Steering Committee on CUCBCSS UG and U.O issued,vide paper read as (3), stating that B.Com Degree holders under both yearly pattern and CCSS UG pattern of Calicut University have been permitted to write additional specialization courses under CCSS-UG pattern after a lapse of one year subsequent to their passing of B.Com Degree Examination, after obtaining private registration, registering in the Vth semester and apply for specialisation papers through SDE in Vth semester, when it is notified.

Vide paper read as (4), U.O No.10096/2015/Admn dated 26.09.2015 revised by deleting the terms "private" and "registering" from the last part.

Vide paper read as (5), School of Distance Education requested to modify the U.O read as (4) so as to make it applicable to the CUCBCSS pattern also.

Steering Committee on CBCSS UG-2014, vide paper read as (6), considered the matter and resolved to modify U.O No.3916/2016/Admn dated 04.04.2016 by permitting B.Com Degree holders under Yearly / CCSS-UG / CBCSS-UG pattern of Calicut University to write additional

specialization courses under CCSS-UG / CUCBCSS UG pattern after a lapse of one year subsequent to their passing of B.Com Degree Examination, after obtaining registration in the Vth semester and to apply for specialisation papers through SDE in Vth semester, when it is notified.

Vide paper read as (7), permission has been granted by Vice Chancellor to implement the resolution of Steering Committee subject to the ratification of Academic Council.

Sanction has, therefore, been accorded to permit B.Com Degree holders under Yearly / CCSS-UG / CUCBCSS UG pattern of Calicut University to write additional specialization courses under CCSS-UG / CUCBCSS-UG pattern after a lapse of one year subsequent to their passing of B.Com Degree Examination, after obtaining registration in the Vth semester and to apply for specialisation papers through SDE in Vth semester, when it is notified.
