Faculty of Engineering-B.Tech Course Regulations 2009-Change in the eligibility for first class-CGPA fixed as 6.0 or above-approved-cancellation of Degree Certificates already issued-sanctioned-orders issued.

ORDER

As per the paper read as (1) above, the Regulations for B.Tech 2009 Scheme was implemented. As per the Regulations Clause 21(b) ('a') and ('b'), the CGPA for first class and first class with Honours were fixed as not less than 6.50 and 8.00 respectively.

As per the paper read as (2) above. sanction has been accorded by the Vice-Chancellor for implementing the resolution of the Academic Council held on 08-06-2015, that the requirement in B.Tech Regulations 2009 Admission for First Class be fixed as CGPA 6.0 or above and that for Distinction as CGPA 7.5 or above for all the 2009 admission students. Those students who have already taken their certificates can be issued a new certificate stating their class, as and when they surrender the previous certificates and apply for a new one.

As per the paper read as (3) above, the B.Tech branch had pointed out some practical difficulties and associated issues in implementing the Clause 21(b) of the B.Tech Regulations 2009, regarding the classification of successful candidates. After considering the matter in detail, the Vice-Chancellor had ordered to place the matter before the Academic Council for re-consideration.

As per paper read as (4) above, the meeting of the Academic Council held on 20-02-2016 vide item No.14 has resolved to continue with the B.Tech Regulations 2009 implemented vide UO to 2009 scheme students. Subsequent changes in the Regulations, relating to successful candidates will not be applicable to 2009 scheme B.Tech students.

The Dean, Faculty of Engineering has conveyed the revised formula for converting CGPA to percentage of marks as follows:-

"Percentage of marks =CGPA x 10 ", replacing the existing formula of "Percentage of marks = CGPA - 0.5 x10".

As per the paper read as (5) above, the B.Tech Branch had sought specific orders of the Vice-Chancellor to cancel the Degree Certificates already issued and to revise the Degree Certificates

effecting class change consequent on the resolution of the Academic Council.

After having considered the matter in detail sanction has been accorded by the Vice-Chancellor for the following:-

- 1) To approve the new formula proposed by the Dean, Faculty of Engineering for the conversion of CGPA into percentage of marks as "percentage of marks = CGPA x 10".
- 2) To fix the fee for revised Provisional Certificate/Consolidated Marklist and Degree Certificate at par with the fee for PC/CML/DC, ie to charge the normal fee of Rs.125/- (Rupees one hundred and twenty five only), Rs.250/- (Rupees two hundred and fifty only) and Rs.325/- (Rupees three hundred and twenty five only) for Provisional Certificate/Consolidated Marklist and Degree Certificate respectively.
- 3) To issue a circular to all affiliated Engineering Colleges and to issue a press release on the matter.

Sanction has, also been accorded by the Vice-Chancellor to cancel the Degree Certificates already issued to all the students of B.Tech who got admission to the course as per the 2009 admission regulations as and when they surrender the certificates already issued to them and apply for revised Degree Certificates in order to effect class change introduced as per the resolution of the minutes of the meeting of the Academic Council mentioned above.

Orders are issued accordingly.
