The Calicut University Bill passed by the Legislative Assembly got the assent of the Governor on the 2nd day of April 1975 and became the Calicut University Act, 1975. The Government had also issued the First Statutes and the First Ordinances of the University thereafter as provided for in section 82 of the Calicut University Act, 1975. These Act, Statutes, Ordinances and Regulations were initially compiled and published by the University in 1980. Several amendments have been issued to the Act, the Statutes, the Ordinances and the Regulations since their issuance. A second edition was published in 1989, incorporating the amendments notified in Kerala Gazette till 1988.

In this revised (third) edition of the book, a sincere attempt has been made to update the University Act, Statutes, Ordinances and Regulations by incorporating all the amendments notified in the Gazette till July 2008.
