ORDER

Vide paper read first, sanction had been accorded for implementing the scheme and syllabus of B.A programme in Sociology under Choice Based Credit Semester System in the colleges affiliated to the University w.e.f 2009 admission.

Vide paper read second, the Board of Studies at its meeting held on 28.07.2011, item No.III (1) resolved to approve the revised syllabus of 5th and 6th semester for 2009 admission for the following core and Elective courses.

- 1) S05 B08 Theoretical Perspective in Sociology
- 2) S05 B09 Social Anthropology
- 3) S06 E01 Sociology of Development

And vide item No.III (2) resolved to approve the revised syllabus of the 3rd , 4th, 5th and 6th semesters for 2010 admission for the following core, Elective and Complementary courses.

- 1) S03 B03 Social Informatics
- 2) S05 B08 Theoretical perspective in Sociology
- 3) S05 B09 Social Anthropology
- 4) S06 E01 Sociology of Development
- 5) S04 C05 Social Anthropology (complementary)

Vide paper read third and fourth, the Faculty of Humanities at its meeting held on 29.02.2012 item No.21(3) and the Academic Council at its meeting held on 24.03.2012 (item No.II (B) has approved the minutes of the meeting of the Board of Studies in Sociology (UG) held on 28.07.2011 item No.III(1,2)and the minutes of the meeting of the Faculty of Humanities held on 29.02.2012 item No.21 (3) respectively.

Vide paper read fifth, remarks was sought from the Chairman, whether the revision can be implemented from 2012-13 admission onwards since 2009 admission has already completed the course and 2010 admission is nearing completion.

Vide paper read sixth, Pareeksha Bhavan has informed that the Examinations of V semester B.A.(Malayalam and Sociology) Double Main (pattern II) for the core course S05 B06/S03B04 (Foundations of Sociological theories) and Elective course S05 E01/S06 E01 Sociology of Development) have not been conducted yet and had sought clarification from this branch whether the changes in the syllabus is applicable for 2009 admission students also.

Vide paper read seventh, U.O.Note was issued to Pareeksha Bhavan seeking reasons for non-conduct of examination, when there was an existing syllabus.

Vide paper read eighth, the Chairman has clarified that the revision of syllabus were required to fit the course into the specified frame of credits and working hours especially in the case of Double Main (Sociology and Malayalam) B.A. programme. Hence the Chairman requested to issue orders making applicable the revisions for 2009 and 2010 admission also.

Vide paper read ninth, clarification was sought from the Pareeksha Bhavan whether the students of 2009 admission of B.A.Malayalam and Sociology faced any difficulties to acquire 120 credits required for passing the course in the pre-revised syllabus.

Vide paper read tenth, Pareeksha Bhavan has clarified that as per the syllabus of 2009 admission, the credits exceed 120 and will be 126. The V semester exam for 2009 admission have been conducted in July as per the syllabus of 2011 admission.

(In addition to this, the students had been taught the papers suggested as per the revised syllabus in 2011 in their V semester. In view of this)

The results of these students will be published only after finalizing this issue and if the publication of results is delayed further, they cannot seek admission for PF this year.

Vide paper read eleventh, Vice-Chancellor has accorded sanction to effect revised syllabus of 2011 admission for 2009 and 2010 admission also.
