ORDER

As per paper read first above,modified Regulations,scheme and syllabus of MBA programme under **Choice Based Credit Semester System(CCSS)** was implemented with effect from 2013-2014 admission onwards.

As per paper read second above,the BOS in Management Studies(PG) at its meeting held on 03.04.2014 vide item No:5 has resolved that since Academic Council has already approved the conversion of MBA part-time course from three year to two year from 2014-2015 academic year onwards, to reject the request of the 2013-2014 batch of students to convert their programme as two year programme.

In this connection it is pointed out that the U.O dated 01.01.2014 implementing the modified syllabus of 25.07.2013, has not mentioned that the modifications relating to MBA(part-time)is applicable to 2014-2015 academic year only as decided by the BOS and subsequently approved by the Academic council. Hence it is resolved to request University to issue an addendum to U.O dt 01.01.2014 to this effect. Further it is pointed out that the first semester MBA(part-time) of 2013-2014 admission, two courses namely **Business Communication** and **Management Theory and Practice**,University examinations were conducted for 2 credits as per Regulation. Hence it is recommended to **convert them to 3 credits at the time of result finalisation.**

As per paper read third above,the Faculty of Commerce and Management Studies at its meeting

held on 20.06.2014 has approved the minutes of the meeting of the BOS in Management Studies(PG)held on 03.04.2014.

Considering the urgency of the matter,the Hon'ble Vice Chancellor in exercising the powers of the Academic Council,has approved Item No: 5 of the minutes of the meeting of the BOS in Management Studies(PG) held on 03.04.2014. Accordingly,the following addendum is issued to the university order read first above,subject to ratification by the Academic Council.

ADDENDUM

The following clause is added to the U.O read as Ist above and it shall be as follows-

Since Academic Council has already approved the conversion of MBA(part-time)course from three year to two year from 2014-2015 academic year onwards, the Board has resolved to reject the request of 2013-14 batch students to convert their programme as two year programme.

It is pointed out that the U.O dated 01.01.2014 implementing the modified syllabus of 25.07.2013, ie modifications relating to MBA(part-time) is applicable to 2014-2015 Academic year only.

It is also pointed out that the first semester MBA(part-time) of 2013-2014 admission, two courses namely **Business communication** and **Management Theory and Practice**, University examinations were conducted for 2 credits as per Regulations. Hence it is recommended to **convert in to 3 credits at the time of result finalisation.**
