**ORDER**

As per paper read First above,the Regulations, Scheme and Syllabus for MBA course was approved and vide reference read Second above, certain modifications were brought in to the Regulations,Scheme and Syllabus of MBA (CUCSS) with effect from 2013-14 admission onwards.

As per paper read Third above, the Board of Studies in Management Studies (PG) at its meeting held on 23-03-2015, vide Item No.1 has considered the suggestion of the Head of the Department of Commerce and Management Studies for modifying Clause 3.1 of CCSS and Clause 3.2 of CUCSS Regulations of MBA programme regarding the minimum test score required for being eligible for MBA admission in the University Department/Centres/Affiliated Management Institutes from 2015-16 academic year onwards and also resolved the following:

**a) To reduce the minimum Test Score required to be obtained by the candidate to be eligible for admission to MBA Programme to 10% for the general candidates and 7% for SC/ST candidates.**

**b) To conduct one CUMAT examination for the year 2015-16 academic year if sufficient number of eligible candidates with the stipulated CMAT score are not available for admission in the University Department/Centres/Affiliated Institutes.**

As per paper read Fourth above,the Acting Dean,Faculty of Commerce and Management Studies, after having considered the urgency of implementing the decision w.e.f.2015-16 academic year, has

approved the resolution of the Board of Studies in Management Studies(PG) on behalf of the Faculty of Commerce and Management Studies.

Considering the urgency of the matter,the Vice Chancellor in exercise of the powers of the Academic Council, has accorded sanction for implementing the resolution of the Board of Studies in Management Studies(PG) subject to ratification by the Academic Council, for modifying the **Clause 3.1 of the CCSS and Clause 3.2 of CUCSS Regulations of MBA programme regarding the minimum test score required for being eligible for MBA admission in the University Department/Centres/Affiliated Management Institutes from 2015-16 academic year onwards and also resolved the following:**

**a) To reduce the minimum Test Score required to be obtained by the candidate to be eligible for admission to MBA Programme to 10% for the general candidates and 7% for SC/ST candidates.**

**b) To conduct one CUMAT examination for the year 2015-16 academic year if sufficient number of eligible candidates with the stipulated CMAT score are not available for admission in the University Department/Centres/Affiliated Institutes.**
