ORDER

Vide paper read first above, orders were issued implementing the Rules and Regulations of CUCSS in the affiliated Colleges of the University.

Vide paper read second above, orders were issued implementing the syllabus of MA Political Science under CUCSS in the affiliated colleges with effect from 2010 admission onwards.

Vide paper read third above, orders were issued implementing the revised syllabus of MA Political Science under CUCSS in the affiliated colleges with effect from 2013 admission onwards.

Vide paper read fourth above, the Board of Studies in Political Science (PG) at its meeting held on 22-01-2013 (item No. 6) resolved that there will be no internal component for Dissertation for CUCSS. It was also resolved that out of eight credits, six credits are to be earmarked for Dissertation/ Project and two credits for Viva- Voce which will be comprehensive in nature.

Vide paper read fifth above, the Chairman has clarified that item No. 6 of the minutes of the meeting of the Board of Studies in Political Science (PG) held on 22-01-2013 is to be made applicable from 2011 admission onwards.

Vide paper read sixth above, the Dean Faculty of Humanities has remarked that instead of six credits for Dissertation valuation and two credits for Viva, four credits each for dissertation and viva voce can be assigned and the four credits for viva can be bifurcated as (i) Viva Voce based on Dissertation - 2 credits and (ii) Viva Voce based on the theory papers taught for the four semesters

(General Viva) - 2 credits.

Vide paper read seventh above, the Chairman, Board of Studies in Political Science(PG) has remarked that the recommendations of the Dean, Faculty of Humanities can be accepted.

Vide paper read eight above, the Academic Council at its meeting held on 30-07-2013 item No. I 18, resolved to approve the minutes of the meeting of the Board of Studies in Political Science held on 22.01.2013 along with the remarks offered by the Dean, Faculty of Humanities vide paper read sixth.

Sanction has therefore been accorded to implement the Academic Council resolution held on 30.07.2013 (Item No. I.18).

Accordingly the following orders are issued with regard to the credits allotted for dissertation:

I. Valuation of Dissertation - 4 credits

II Viva Voce

(i) Viva Voce based on Dissertation - 2 credits

(ii) Viva Voce based on the theory papers

taught for the four semesters (General Viva) - 2 credits

Orders are issued accordingly implementing the credits allotted for dissertation with effect from 2011 admission as detailed above.

The UO read third above stands modified to this extent.
