Part I English : 30 marks

Part II General Knowledge : 30 marks

Part III Arithmetic and Logical Reasoning : 30 marks

Part IV Social Work Aptitude : 10 marks (Two short questions of five marks each)

The examination will be of one and a half hours duration.
